Section 4 – Hazards Identification



Eye:Causes eye burns.Skin:Causes skin burns. Harmful if absorbed through the skin.Ingestion:May cause irritation of the digestive tract. Toxic if swallowed.Inhalation:May be harmful if inhaled. Causes respiratory tract irritation.

Section 5 – First Aid Measures
