Section 4 - Hazards Identification

Eye: Causes eye irritation.

Section 6 - Stability and Reactivity

Chemical Stability: Stable under normal temperatures and pressures.

Storage: Store in a cool, dry place. Store in a tightly closed container. Store at 2-8 deg C
