Section 4 – Hazards Identification

Eye: Causes eye burns.
Skin: Causes skin burns. Harmful if absorbed through the skin.

Ingestion: May cause burn of the digestive tract. Toxic if swallowed.

Inhalation: May be harmful if inhaled. Causes respiratory tract burns.

Section 5 – First Aid Measures

Eye: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water and soap for at least 15 minutes while removing contaminated clothing and shoes. Get medical aid if irritation develops and persists.

Ingestion: Get medical aid immediately. Wash mouth out with water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Section 6 – Stability and Reactivity

Chemical Stability: Stable under normal temperatures and pressures.

Materials to avoid: Strong oxidizing agents.

Conditions to Avoid: Incompatible materials.

Hazardous Decomposition Products: Carbon monoxide, carbon dioxide, hydrogen fluoride gas.

Hazardous Polymerization: Will not occur.

Section 7 – Handling and Storage

Handling: Avoid breathing dust, vapor, mist, or gas. Keep container tightly closed. Avoid contact with skin and eyes. Wash thoroughly after handling. Mechanical exhaust required.

Storage: Store in a cool, dry place. Store in a tightly closed container. Keep away from sources of ignition.
