### Section 4 – Hazards Identification

**Eye:** Causes eye irritation. Lachrymator (substance which increases the flow of tears).

## Section 5 – First Aid Measures

**Ingestion:** Get medical aid immediately. Wash mouth out with water.

**Inhalation:** Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

## Section 6 – Stability and Reactivity

**Chemical Stability:** Stable under normal temperatures and pressures.
