Section 4 – Hazards Identification

Eye: Causes eye irritation.
Skin: Causes skin irritation. Harmful if absorbed through the skin.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Section 6 – Stability and Reactivity

Chemical Stability: Stable under normal temperatures and pressures.

Materials to avoid: Strong oxidizing agents, strong acids.

Conditions to Avoid: Incompatible materials, strong oxidants.

Hazardous Decomposition Products: Nitrogen oxides, carbon monoxide, irritating and toxic fumes and gases, carbon dioxide, nitrogen.

Section 7 – Handling and Storage

Handling: Avoid breathing dust, vapor, mist, or gas. Keep container tightly closed. Avoid contact with skin and eyes. Wash thoroughly after handling. Mechanical exhaust required.
